**欧州事業拡大に向けたS J N K Eの  
SOMPOインターナショナル傘下への移行について**

SOMPOホールディングス株式会社（グループCEO 代表取締役社長：櫻田 謙悟、以下「SOMPOホールディングス」）傘下のSOMPOインターナショナルホールディングス（会長兼CEO：ジョン・シャーマン、以下「S I H」）は、Sompo Japan Nipponkoa Insurance Company of Europe Limited（以下「S J N K E」）を5月1日付でS I Hの完全子会社としたことを発表しました。

S I Hは、先日、欧州における新たな子会社であるSI Insurance (Europe), SA（以下「S I I E」）の設立認可をルクセンブルク財務大臣から3月27日付で取得したことを発表しておりますが、同社は本社のあるルクセンブルクに加えて、各国の関係当局の認可を前提として、ベルギー、フランス、ドイツ、イタリア、スペインを含めた欧州各国での事業拡大を進めていく予定です。S I I Eは、2018年下期の営業開始を見込んでおりますが、S J N K Eの欧州大陸における事業はその後S I I Eへと移管する予定です。一方、ロイズマーケットおよびロンドン市場においては、それぞれEndurance at Lloyd's LimitedおよびEndurance Worldwide Insurance Limitedによる事業を継続する予定です。

また、スタンダード&プアーズによるS I H傘下の中核子会社の財務格付けが「A」から「A+」に引き上げられたことに伴い、S I I Eについても同様に「A+」の財務格付けを取得しました。

## **Sompo International Continues European Expansion with Transfer of SJNKE**

PEMBROKE, Bermuda – May 7, 2018 – Sompo International Holdings Ltd. (Sompo International), a Bermuda based specialty provider of property and casualty insurance and reinsurance, announced today that the integration of Sompo Japan Nipponkoa Insurance Company of Europe Limited (SJNKE) into Sompo International reached a significant milestone on May 1, 2018 as SJNKE became a wholly-owned subsidiary of Sompo International.

Sompo International previously announced that its new subsidiary, SI Insurance (Europe), SA (SIIE), received regulatory approval from the Ministry of Finance of Luxembourg on March 27, 2018. SIIE is expanding beyond its headquarters in Luxembourg to include operations in Belgium, France, Germany, Italy and Spain, subject to required regulatory approvals. Once SIIE becomes operational later in 2018, SJNKE's Continental European business will transfer to SIIE. Sompo International will maintain its presence in the Lloyd's market with Endurance at Lloyd's and the London company market with Endurance Worldwide Insurance Limited.

SIIE has been assigned an "A+" financial strength rating from Standard & Poor's (S&P) in line with S&P's recent upgrade of the financial strength ratings of Sompo International's core operating companies to "A+" from "A". SJNKE holds an "A" financial strength rating from S&P.
