## SOMPOインターナショナルによるロイズ事業の売却

SOMPOホールディングス株式会社（グループCEO執行役会長：櫻田 謙悟）傘下の Sompo International Holdings Ltd.（以下、傘下グループを総称して「SI」）は、2020年12月末をもってロイズのシンジケートを通じた保険引受を終了し、2021年1月から SI グループ会社の Endurance Worldwide Insurance Limited（英国）による引受に統合することをご案内していました。2022年8月30日、ロイズのランオフ事業を RiverStone Holdings Limited（RiverStone International）に売却し、英国マーケットのプレゼンスを1社に統合するという既発表の目標を事実上完了いたしました。
