### **Establishment of Group Chief Officer System and Organizational and Personnel Changes**


Sompo Holdings, Inc. (President & CEO: Kengo Sakurada, the "Company") will establish a Group Chief Officer system (the "Group CxO system") on April 1, 2017, following on from the business owner system adopted in the fiscal year ended March 2016. The Group CxO system will serve as a Group management system to realize the Group's management philosophy of "providing customers with services of the highest quality to contribute to their security, health, and wellbeing." Along with the establishment of the CxO system, the Company also wishes to announce that it will implement organizational and personnel changes as described in the attachment.

#### 1. Establishment of Group CxO System

Following on from the business owner system, the Company will establish the Group CxO system\*. Under the Group CEO's leadership of the entire Group, each business will be entrusted to the four business owners. With this structure in place, the Company will appoint officers responsible for each functional area, specifically Group CFO, Group CRO, Group CACO, Group CIO, Group CDO, and Group CHRO.

Through these measures, guided by the Group's management strategy, the Company will further strengthen its framework for conducting optimal Group-wide decision-making and business execution more rapidly and flexibly in response to disruptive changes in the environment. By doing so, the Company will work to achieve sustainable growth.

\*The assigned officer system that has been in place to date will be abolished. The title of Group Chief Officer, which was previously used as a descriptive title by executives other than the Group CEO, will be officially defined in terms of a "function portfolio" that prescribes their roles, functions, authority, personnel requirements and other attributes. At the same time, these attributes will be linked to executive remuneration and succession planning.
